Small project found

Friuli Venezia Giulia helps cross-border cooperation

The project puts forward as its general objective the management of a fund intended to finance small projects in the various spheres of cross-border collaboration admissible under the Programme through the publication of an appropriate grant announcement.

The addressees of this announcement will be those in the territory who normally do not have sufficient resources of their own and know-how to be able to start any form of collaboration with subjects located beyond the border. In principle, it deals with Municipalities, schooling institutions, associations and not-for-profit organisations.

The Inter-regional IV Italy-Austria Programme for cross-border cooperation is a Programme of Community initiative that puts into effect cross-border cooperation and involves the Regions of Friuli Venezia Giulia and the Veneto, the Autonomous Province of Bolzano-Alto Adige and some Austrian Lander in Carinthia, Salzburg and the Tirol. The overall objective of the programme is to promote balanced, sustainable and lasting development and the harmonious integration of the cross-border areas that are characterised by natural and administrative barriers in the wider territorial context to reinforce the attraction and competitiveness of the region and its subjects/players through the fol-



lowing specific objectives:

• Improvement of economic relations and competitiveness

• Protection of the environment and sustainable development of the territory

• Support for assessment and improvement of administrative capabilities

Therefore, there has been approval within the scope of the Inter-regional IV Italy-Austria Cooperation Programme for the already-mentioned project for a **Small Project Fund**, , with the participation of Carinthia as lead partner and the Friuli Venezia Giulia and Veneto Regions as project partners. In order to present the programme and its possibilities an informative day has been organised that will take place in Udine in the regional offices in Via Sabbadini 31on 8th February next. This occasion will illustrate the contents, the methods of working and the procedures for submitting project proposals in the sphere of the referred to announcement. The right to information and freedom of expression constitutes the heart of democracy in Europe. Such principles are made clear in the EU Treaty and the European Charter of Fundamental Rights. This must be the starting point for a process aimed at defining common principles and a common vision for the communications policy of the EU. The communication strategy of the European Union is aimed at guaranteeing to its citizens full participation in the democratic life of the Community.

The determining decisions in the daily life of the citizens could be adopted in the most transparent possible manner and carried out in close relationship with those citizens, through the use of various communication services.

To reach this objective, the synergies between the European Union and local bodies, regional and national, is fundamental, like that of cooperation with representatives of civilised society. European communication has lead the way many times and to shorten the distance between the European Union and its citizens the Commission has decided to fully put into practice the White Paper on European communication policy that is based on five fundamental points: the definition of common principles, involvement of its citizens, collaboration with the media and the use of new technologies, understanding European public opinion and cooperation.

Without anticipating any great change in the operating organisation for communications strategy of the European Union, it is evident to all those who work in the information sector that wider collaboration, with the local level and between the Community information networks, would be fruitful for all citizens and for public and private bodies.

To improve the standard of communication and

the reciprocal exchange of information within the European Union, the principle means that one uses today is the web.

The role of the Internet in the daily life of the citizens has grown exponentially and today, with more than half of the population connected, it represents a more and more relevant instrument for communication and exchange of ideas. The Internet can help Community institutions to understand public opinion, assisting debate at a

Community level on common topics, an open discussion and in real time between people of different countries who recognise each other as citizens of the Union having legitimate interests in the debate. The communications strategy regarding Italy concentrates on four fundamental themes, that is to say the defined objectives of the Lisbon strategy, namely growth, employment and competitiveness; the area of freedom, justice and security (particularly topical in Italy because it considers its frontiers more exposed, given its geographic position, to the wave of illegal immigrants from the Mediterranean); the objectives of the Gothenburg strategy, that is sustainable development and environmental protection; and finally solidarity between the generations. On the basis of these, Friuli Venezia Giulia Region has itself set out its own communications strategy with regard to the Structural Funds and "FVG Europe Objective" was born right among these strategies.

To create participation and awareness among our citizens regarding the opportunities offered by the European Regional Development Fund, the main means the Region uses is the Internet site of the ROP ERDF, in addition, to be remembered, are the publications in the principal regional daily newspapers and the various conferences that are organised to inform, explain and promote the grant announcements approved by the Regional Council that concern the Funds in question.

In conclusion, it also leads me to inform readers of an important innovation regarding communications, the creation of a multimedia platform.

This important innovation provides multi-channel management of the activities of direct and relationship marketing transmitted across digital channels of communication.

In summary, through free registration, the technical platform allows e-mail receipt of all the news concerning the ROP ERDF 2007-2013 such as the approved grant announcements, the organisation of conferences and seminars and other useful information.

The system will also allow users to personalise the wanted information requests and participate in surveys regarding various types of topic.

Friuli Venezia Giulia continues to work to encourage its citizens to take part in the life and opportunities that the European Union offers for being more and more competitive, renewing its own activity.

Help for the Mountains

ROP EDRF 2007-2013 Grants Announcement for mountain development

The general objective of the ROP is to support competitive development and employment in all of the Regional territory. From analysis of the Regional situation some areas are highlighted for their specific social, economic and geographical nature that require further and more targeted intervention, additional to those of a general nature and provided for across the entire Region. They are urban, mountain and lagoon areas. Axis 4 of the ROP "Territorial Development" provides for a group of measures that, being concentrated on restricted areas of the territory, respond more effectively to local needs and can therefore contribute to a reduction in the specific imbalances that characterise such areas.

Activity 4.2.a. puts into effect the territorial development strategy for the mountain areas through the exploitation of the natural, cultural and local scenic resources to support productive activities able to positively impact upon economic growth and to augment the attraction of the territory. Operations carried out under Activity 4.2.a, like all the measures under Axis 4, must form part of an integrated territorial programme. In the case of the mountain areas, the Region has adopted C.I.M.A, the instrument for Coordination and Integration of Mountain Areas in the sphere of ROP ERDF 2007-2013. This instrument is adopted for integrated local planning represented by the Local Action Plans (LAP) presented by the mountain Municipalities and by the Provinces of Gorizia and Trieste (for the Karst area) to the Region, as per Regional Law 4/2008, and coordinates them into a Regional brief that is also in keeping with the purposes of the ROP.

In the context of intervention within Activity 4.2.a of the ROP and C.I.MA, the Regional Council has approved in December 2009 four grant schemes for the award of contributions to Municipalities, businesses and private individuals from mountain areas in the Region. Shown below are the concise details.

12 public announcements for grants of over 100 million Euros

The Regional Administration, steadfastly following its policy of supporting the production sector in our Region at a time that is particularly delicate in the context of the first signs of economic recovery, is launching an important signal to business. In fact, on the 28th January 2010 the Regional Council approved three announcements of access to worthwhile Community contributions to the Regional Operational Programme (ROP) for public works of the European Regional Development Fund (ERDF) having the "Objective of Regional competitiveness and employment" in our Region.

It deals with announcements that are part of 'Axis 1 of the ROP ERDF, "Innovation, research, technology transfer and entrepreneurship" - Activity 1.1.a "Incentives for industrial research, development and innovation" – in favour of artisan businesses, industry and the commercial sector, the tourism sector and services (SMEs, large businesses, consortiums,..) according to the methods and requirements with regard to the various activities that can be financed, established by the related announcements.

The announced financial resources amount to 40,000,000 Euros for the industrial sector and 7,000,000 for the artisan sector. Instead, for the single announcement that covers both the commercial sector and tourism, the available resources are equal to, respectively, 5,500,000 Euros for the benefit of commercial businesses and 3,500,000 Euros in favour of those operating in the tourism sector.

In general and with appropriate distinctions related to the sector under consideration, the initiatives that can be financed are for the purposes of undertaking research and experimental development projects, for innovation projects concerning production processes and company organisation, as well as, for notable innovations, the achievement of programmes to industrialise the research results, that is to say production investments strictly connected with and complementary to the industrialisation of the project findings achieved by the recipient businesses. As regards the form of contribution, it is granted as non-refundable assistance, calculated on the basis of the percentages and the strength of the connection with the admissible specific initiatives for financing and/or the size of business.

All the announcements introduce both a minimum limit of admissible expenditure for each request made, that varies, also in this case, depending upon the sector involved and the size of



the business, and a maximum limit of granted contribution for each business that, for the artisan and commerce/tourism sectors amounts to 1 million Euros, while for the industrial sector it goes up to 2 million Euros.

The grant requests must be presented to the qualified central Management Services for the Production Sector for subsequent preliminary investigation and evaluation of the expected selection criteria in order to be usefully placed on the list and access the requested contribution grant.

Such initiatives represent only one stage of the process of operating the ROP ERDF programme "Objective of Regional Competitiveness and Employment" 2007/2013, which has seen the Regional facilities chiefly employed in guaranteeing the most ample return to the Regional territory of Community resources entrusted by the European Commission to the Friuli Venezia Giulia Region, equal to around 303,000,000 Euros for the whole 2007/2013 period.

Under the aegis of the "claim" that identifies the programme: "let's invest in our future" the Regional Council has concentrated the maximum operating efforts of its Offices to ensure that Community resources can be of utmost use in the territory.

In fact, since the 23rd September 2009, 12 announcements and 1 invitation have been approved for an overall value of 101,000,000 Euros at the rate of about one announcement per week. The intense work of the Regional Offices with the coordination of the Community Policies Service of the central Management of international and Community relations, as Managing Authority of the Programme, is authorised to offer investment opportunities in initiatives promoting competitiveness and innovation, in other words for research and practical development, to everybody belonging to the entrepreneurial world, public and private research and University research. It ranges from grants aimed at promoting the development of the architectural and industrial heritage in favour of local bodies, singly or as associates, for a total value equivalent to 4,235,000,000 Euros up to the financing of complex projects for industrial research of high systemic impact on strengthening the research and innovation networks and the technical innovation districts in the home automation, molecular biomedical, shipbuilding and pleasure boat sectors (overall 12,000,000 Euros) in favour of small and medium busines-

ses, large businesses, management bodies of science and technology parks, research bodies and universities. No production sector has been excluded or forgotten; all interests, both economic and environmental, have been safeguarded. For the purpose of promoting and augmenting business competitiveness, to guarantee the attractiveness of tourism and the protection and safeguarding of the territory, the Regional Council has approved initiatives to finance projects aimed at converting the heat sources of public buildings through the exploitation of geothermal resources (heat pumps) to a value of 3,080,000 Euros. Almost in the same context, the Friuli Venezia Giulia Tourism Agency has provided finance of 5,500,000 Euros for the development of an integrated computer system for promoting and boosting access by tourism businesses and the entire community to the network of services offered by the Region to this sector, in a manner such as to permit both integrated marketing of the Regional tourism system and the growth of competitiveness of the businesses in the market. Alongside the work carried out by the central Management of production activities, that with only 4 grant announcements aimed at promoting the development of commercial and artisan industries, in total has committed more than 50% of the resources "put to work" (56,000,000 out of 101,000,000), it is to be pointed out that the activity carried out by the policy coordination Service for the mountains of the President of the Region with 4 grant announcements, to a value of around 20,000,000 Euros, has pledged all the arrangements under the Programme to promote development of the mountainous area in the Region - concentrating them mainly in the "widespread hotels" set-up first promoted and developed by our Region and much appreciated by the European Commission as being, by the same Brussels offices, "best practice" on the European level that should be financed with Community money without forgetting the promotion of socio-economic development of the mountain area. In fact, in the same context, the development of economic activities connected with the cultural and natural heritage is favoured, improving accessibility, stimulating the sustainable use of natural resources and encouraging sustainable tourism right in that part of the territory that largely experiences the period of crisis.

In the month of December four lines of finance were started to assist the exploitation and enjoyment of the natural and cultural resources and the existing heritage in the mountain area, with the publication of announcements for the award of grants in favour of the mountain communities, private and micro and small businesses, that include besides the realisation and exploitation of the widespread hotels, old and new, also the performance of restoration operations and/or infrastructure redevelopments, public areas, itineraries and equipping of routes
